## 2017-18 Tuition Information

**TUITION** - Catholic East offers a discount for 2 children or more from the same family in Grades K4-8. Here are tuition figures, including this discount where applicable:

A \$50 non-refundable registration fee will be required to hold a K3 spot. This fee will be applied toward tuition if your child attends in the fall.

**KIDS CAMPUS -** Our before- and after-school enrichment program is staffed by certified teachers. The 2017-18 cost is \$3.75 per hour per child with a discount for siblings (for 2 children, \$3.25 per child per hour; for 3 children, \$3.00 per child per hour). Kids Campus is available to students who need care daily as well as to students who need care only occasionally. Kids Campus opens at 7AM and closes at 6PM at both campuses.

**MEALS** – For the 2017-18 school year, Gr. K3-8 breakfast (with milk) is free, hot lunch (with milk) price is TBD and just milk to go with lunch from home is 40 cents per carton. Some families may qualify for free or reduced cost (40 cents per day) lunch. Applications are sent home at the beginning of the school year. Lunch and milk fees subject to change with notice.

**ATHLETICS** - \$40 fee per sport, including a \$5 refundable uniform deposit

**FIELD TRIPS** - Fee assessed when planned

Catholic East accepts a limited number of students through the Milwaukee Parental Choice Program. Please see the reverse side of this sheet for the 2017/18 Income Limits for New Students to see if you qualify. Please contact the Director of Admissions and Marketing for details. K3 is not part of the Choice program.



## 2017-18 Income Limits for New Students

Milwaukee Parental Choice Program (MPCP) and Racine Parental Choice Program (RPCP)

For the 2017-18 school year, the family income of a student new to the MPCP or RPCP program must be at or below the amount listed in the table below. If a student is continuing in either program or was on a choice waiting list at a choice school in the prior year, he or she is no longer required to meet the income limits. Family income includes the income of the student's parent(s) or legal guardian(s) that reside in the same household as the student applicant. If the student's parents/legal guardians are married their income is reduced by \$7,000 when determining income eligibility for the program. Family size includes parents/legal guardians and their children by birth, marriage or adoption that reside in the same household as the student applicant.

A private school may, in addition to the state aid payment it receives, charge a choice student tuition in an amount determined by the school if both of the following apply: (a) the student is in grades 9 through 12; and (b) the family income of the student exceeds 220% of the federal poverty level as listed below. The private school makes the determination whether the school can charge a choice student tuition in grades 9 through 12. The private school must establish a process for accepting appeals to the school's governing body related to the school's determination to charge a choice student tuition based on the student's family income.
